### **Eligibility/Criteria**

All mediums are accepted, including 2D & 3D. Art specifications for exhibiting:

- Art must be hand crafted or original work of the artist - No work from workshops or classes, unless made at TCRA class, and no work using copyrighted source material unless you own the copyright.
- Creativity and originality
- Clean
- Presentation
- Craftsmanship
- All entries must be considered suitable for general viewing (no obscenities, nudity, offensive language, or political gestures)

### **Subject Requirement**

SPOOKY EXHIBITION / Sept 21 - Oct 27, 2024

In the spirit of October shenanigans, we are hosting all art of the spooky season. From skulls, to cemeteries, witchcraft, ghosts, and more. Deadline to submit / Art drop off: Wed. Sept 18 (9-4pm CST) + Art Pick up: Wed. Oct 30 (9-4pm CST)

## Entry Requirements

- Only one application per artist.
- Up to **5 entries per TCRA MEMBER artist.**
- And up to 2 entries for Non-Member artists.

## Artist Categories/Guidelines

**MUST BE READY TO HANG WITH WIRE BACKING, NO EXCEPTIONS.**

- Painting – both framed/unframed (please note in your application)
- Metal Art/Jewelry – accompanied on stand, board or display
- Ceramics– May use TCRA table
- Drawing – Loose paper will be clipped on guide wire
- Wood media – may be displayed on table, if hanging is required, please supply assembly
- ALL 2D and 3D MEDIUMS ACCEPTED / Must pertain to show theme (page 1)

## Art Review & Acceptance

- Please bring art and the signed waiver to one of our drop off dates listed above.
- Acceptance is based on the criteria listed under Eligibility and Criteria.
- We reserve the right to refuse any application. All decisions are final.

## Art Sales

- All artwork submitted must be for sale at a fair market price. Please price work to sell, and consider quality, technique, and experience of you and your art.
- Art must be for sale at a fair market price to sell.
- The price of art is determined by the artist. Art price may not be changed after the application is submitted.
- **Posted selling prices include 7 % sales tax. A commission of 20%, and a 3% credit card fee (when applicable) will be deducted from the posted price. Processed checks will be mailed to artists within 10 days of the end of the show. If an artist's sales exceed \$600, the artist will be required to submit a Form W-9 before the proceeds are forwarded. Sold artwork may not be replaced by the artist.**

## Pick-up of Accepted Artwork

- The show closes on Oct 27, the official art pick up will be on Wed 10/30, 9-7pm.
