Tickets are on sale now \$40 single, \$75 couple.

Eligibility/Criteria

All mediums are accepted, including 2D & 3D. Art specifications for exhibiting:

- Art must be hand crafted or original work of the artist - No work from workshops or classes and no work using copyrighted source material unless you own the copyright.
- Creativity and originality
- Clean
- Presentation
- Craftsmanship
- All entries must be considered suitable for general viewing (no obscenities, nudity, offensive language, or political gestures)

Entry Requirements

- Only one application per artist. Up to 5 entries per artist. Please include:
 - Name, City of Residence, Title of Artwork
 - Sale Price (if applicable) OR EXHIBITION ONLY (NFS)
 - Photo samplings of work.
 - (AGE if under 18)

Artist Categories/Guidelines

- **ENTRIES MUST BE MADE ON OR MADE OF PAPER TO BE ACCEPTED.** Including but not limited to: photography, paintings on paper, collages, graphite and charcoal drawings, written word and poetry, paper sculptures, origami, etc.

Art Review & Acceptance

- Please bring art and the printed application to one of our drop off dates listed above.
- Acceptance is based on the criteria listed under Eligibility and Criteria.
- We reserve the right to refuse any application. All decisions are final.

Art Sales

- All artwork submitted must be for sale at a fair market price. Please price work to sell, and consider quality, technique, and experience of you and your art.
- Art may be for showcase only if desired by the artist (specify NFS)
- The price of art is determined by the artist. Art price may not be changed after the application is submitted.
- Posted selling prices include 7 % sales tax. A commission of 15%, and a 3% credit card fee (when applicable) will be deducted from the posted price. Processed checks are available at art pickup date. If an artist's sales exceed \$600, the artist will be required to submit a Form W-9 before the proceeds are forwarded. Sold artwork may not be replaced by the artist.

Pick-up of Accepted Artwork

- All artwork must be picked up Thursday, March 2 between 5:30-7pm CST. Accepted artwork may NOT be removed before the end of the show. Exception: art sold to a buyer, must take it when purchased. *Please bring your picture identification. A Signed authorization is required if picking another artist's entry(s).*
